Do you need help applying for SNAP benefits?



***SNAP Guidelines within for EVERYONE
except students age 18 - 49***

Effective 10/1/24 - 9/30/2025

What is SNAP?

The Supplemental Nutrition Assistance Program (formerly known as food stamps) provides food assistance to families and individuals with low or no income in the U.S. It is a federal program administered by the USDA, but distribution of benefits is determined and done on the state level. A household that qualifies for SNAP receives an EBT card that can be used at any store that accepts it to purchase groceries.



Why should I apply?

- SNAP is the most effective tool for combating hunger in the US. It's estimated that SNAP reduces poverty in the US by as much as 30%.
- SNAP has been linked to improved education achievement in households where students receive it.
- SNAP is associated with better health outcomes and lower medical costs for recipients.
- SNAP empowers you to decide what you and your family eat.

Quick Eligibility Guide

- Only US Citizens and certain lawfully present non-citizens are eligible.
- Both earned and unearned income are considered for monthly gross income.
- Net income is calculated by subtracting your deductions from your gross income. The FSSA has its own list of deductions!
- The household must have less than \$5,000 in assets. eg: Money in the bank or recreational vehicles.
- A household includes everyone who lives together AND purchases/prepares food together.

General Guidelines

| 1 | \$1,255 | \$1,632 |
| 2 | \$1,704 | \$2,215 |
| 3 | \$2,152 | \$2,798 |
| 4 | \$2,600 | \$3,380 |

Households With Elderly or Disabled Members**

| People in Household | Monthly Net Income Limit | Monthly Gross Income Limit |
|---------------------|--------------------------|----------------------------|
| 1 | \$1,255 | \$2,071 |
| 2 | \$1,704 | \$2,811 |
| 3 | \$2,152 | \$3,551 |
| 4 | \$2,600 | \$4,290 |

What to Expect After Applying for SNAP

1. Eligibility Interview:

You must have either a phone or in-person interview with an FSSA eligibility specialist.

A) **Scheduling:** FSSA will contact you by phone or mail to schedule your interview.

If you have not received interview information within 1 week of applying, please call FSSA at: 800-403-0864.

2. Submit Verification Documents:

You will need to provide verification documents.*

You will be mailed a list of documents needed to complete your SNAP application. **You will not receive your EBT card or benefits without the submission of verification documents.**

3. Eligibility Determination:

Once your documents are received, you will be mailed a notice of application status. If approved, the letter will include your EBT card and your awarded amount.

**** Elderly is defined as adults 60+. Households containing only elderly and/or disabled members must only meet the Net Income and Asset Requirements to be eligible for SNAP.**
